### EOQ National Representative Organizations (NR)

- The EOQ NRs must have been an EOQ associated or affiliated (non for profit) member for at least 3 years (exceptions can be made under certain conditions), be able to demonstrate its Quality Management System, be willing to share its know how at European level, formally commit to an active contribution and participation in EOQ activities and show data stating these
- The EOQ National Representative organization supports and promotes in an active manner EOQ key products and services in its own country, has a significant impact in its country in promoting Quality in its broadest sense, be willing to integrate the spirit of the vision and mission of EOQ
- The membership status of an organization as EOQ National Representative has a validity of 5

- to encourage governments at all levels to promote quality;

- to act, on a scientific point of view, as a certification body for personnel, systems and products;
- to establish a forum for the exchange of ideas and information between the members of the association, and other international or European organizations on the necessity of research in quality;
- provide the members with assistance and collective services reserved for the members, as well as the organization of conferences and seminars, the publication of information letters and the provision of information in the broadest way.







### **Ownership**


- EOQ is the owner and has the rights to brand and products & services and is the manager.



## **Implementation**

### **Strategy**

To own, manage and provide harmonized products and services to national representatives as members

### **Organizing**

- 1. EOQ to establish a user forum per product (National Representatives) to:
  - a) Manage the EOQ products
  - b) Maintain and develop the EOQ product
  - c) Verify its implementation in the national representatives organizations according to its harmonized scheme/structure
- a) The National originator member organisation to be invited to Chair the user forum
- 1. The National representatives to adopt the organizational requirements to the EOQ product

This is supporting existing practice in PRU and EOQ management



## Ownership implementation

A contract to be established between EOQ and the respective National Quality Association

- 1. EOQ and the National Representatives wanting to implement a product establish an agreement with EOQ regulating conditions
- 2. The National Representative in a country implement the product as defined and supported by EOQ as product owner
- 3. National product adoptions to be agreed by EOQ in the user forum
- 4. First step is "Recognized by EOQ"
